

Morgan Lake Campground offers a variety of camping experiences. In addition to the family sites in the main campground, a separate group site is available that can handle up to 25 people. Morgan Lake is a clear, 45 acre lake where only electric motors are allowed. All-Terrain Vehicles (ATV's) and Utility-Terrain Vehicles (UTV's) are permitted in this campground as the campgrounds location provides direct access to hundreds of miles of ATV routes and trails.

Campground Fees

Interagency Pass discounts apply only to the fee for the campsite physically occupied by the pass holder.

ATV/UTV Rules and Regulations

- Must stay on gravel surfaces. No parking or driving off of road or campsite.
- Vehicles are to be used for entering and exiting campground. No joyriding within campground.
- Do not drive in water or on lakes edge.
