**Buffalo Lake Campground**, sites 2001-2052, is located in the southern portion of the forest and is on the southeast corner of Buffalo Lake. The 104-acre lake is known for panfishing and there is a boat landing and trailer parking within the campground. The popular mowed grassy beach is known for its sandy bottom. This rustic campground has relaxation and many roomy sites to offer. **Camping reservations are required and can be made for the same day of your arrival or up to 11 months in advance of your planned date of occupancy. Campers must make a reservation before setting up on any site.**

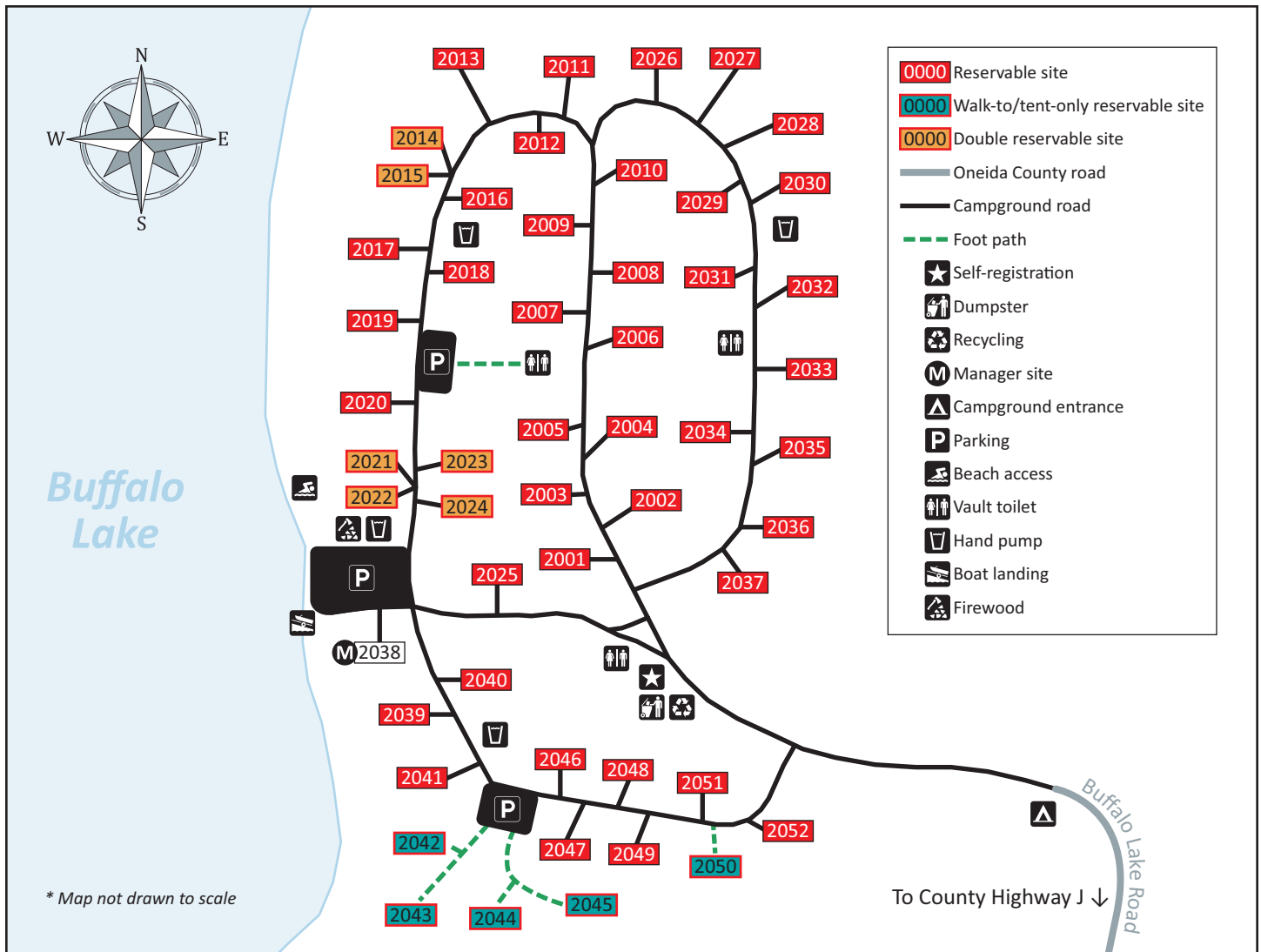

## CAMPGROUND RULES

- Campers must make a reservation before setting up on any site.
- **Checkout Time:** Must vacate site by 3 p.m. on the last day of the permit.
- **Campground/Day-use Areas and Closing Time:** Campground closed to nonregistered campers 11 p.m. to 6 a.m.
- **Pets** must be on a leash at all times and not left unattended.
- **Generators** may be used from 10 a.m. to 5 p.m.
- **Noise** may not interfere with the enjoyment of the forest by others.
- **Camping Party:** A “non-family group” may not exceed six people. A “family” is limited to parents with their dependent children and not more than two guests.
- **A State Parks and Forest Admission Sticker** is required for camping.
- For complete rules and regulations, see Chapter NR 45, Wis. Admin. Code, or contact DNR Law Enforcement.
