**West Star Lake Campground,** sites 1701-1718, is in the east central portion of the Northern Highland American Legion State Forest on Star Lake. The lake provides clear water swimming opportunities and the campground has a designated beach area to enjoy. Star Lake is also known for quality fishing and boating experiences, and the campground has a boat landing available for registered campers. You may access the Star Lake Nature Trail from the campground. **All sites are reservable and campers must make a reservation before setting up.** Reservations can be made up to the day of arrival and no more than 11 months in advance.



#### **CAMPGROUND RULES**

- All campers must make a reservation before setting up on any site.
- Checkout Time: Must vacate site by 3 p.m. on the last day of the permit.
- Campground/Day-use Areas and Closing Time: Campground closed to nonregistered campers 11 p.m. to 6 a.m.
- **Pets** must be on a leash at all times and not left unattended.

• Generators may be used from 10 a.m. to 5 p.m.

- Noise may not interfere with the enjoyment of the forest by others.
- **Camping Party:** A "non-family group" may not exceed six people. A "family" is limited to parents with their dependent children and not more than two guests.
- · A State Parks and Forest Admission Sticker is required for camping.
